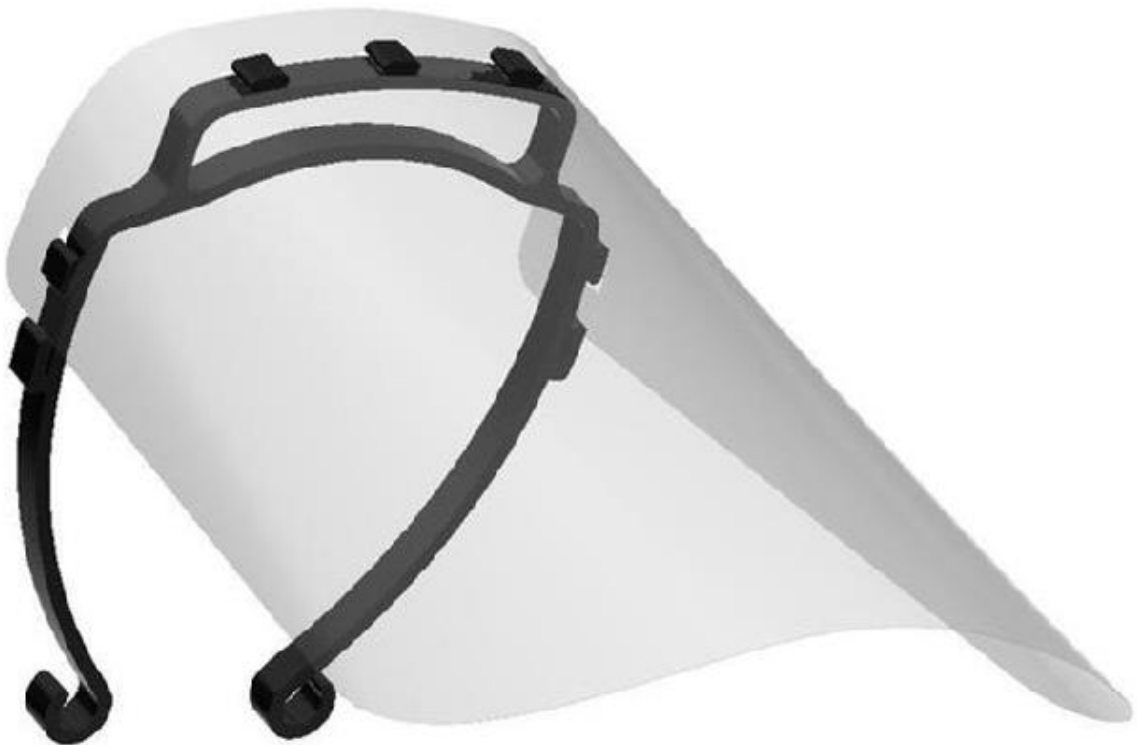

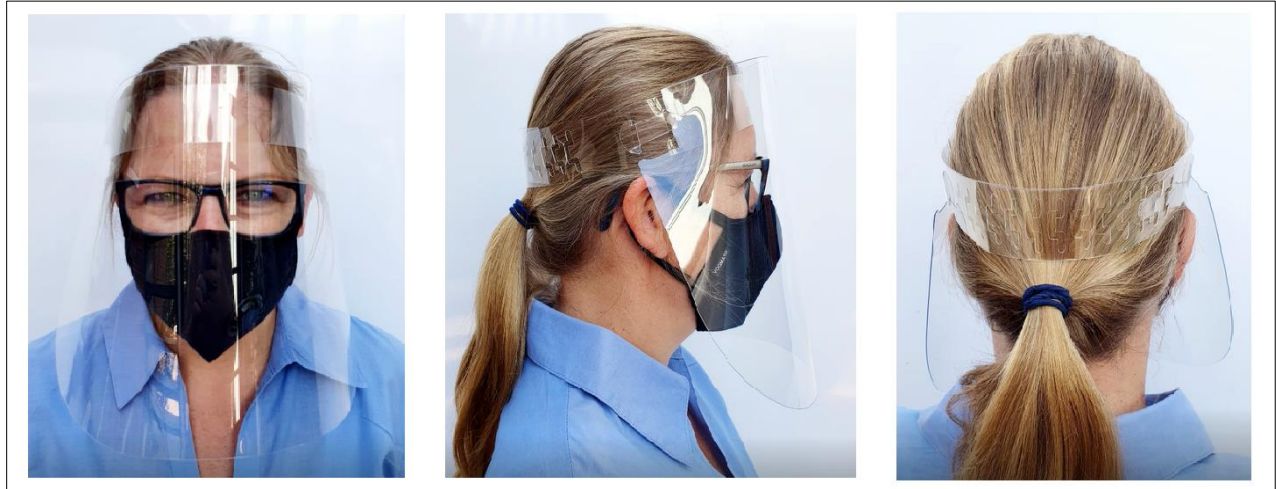

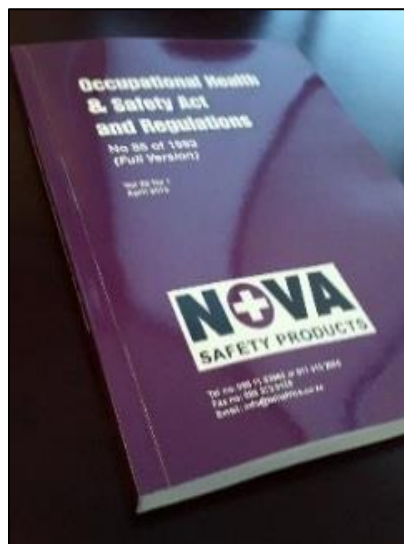

FIRST AID KITS

▪ FIRST AID KIT – LARGE



A good guideline is to ensure there is one large first aid kit per workplace area or trained first aider. The Act requires placement of first aid kits as follows:

"The employer must provide a first aid box or boxes at or near the workplace, available and accessible for treatment of injured persons at the workplace"

▪ FIRST AID KIT – SMALL



The Act requires first aid facilities must be provided

"where more than five employees are employed at a workplace"

■ FIRST AID KIT – VEHICLE



Traveling to and from the workplace is generally undertaken in one's personal capacity, however travel required for work purposes can be deemed a workplace and we recommend having a first aid kit available.

■ FIRST AID KIT – REFILL (REG 3)



A Regulation 3 refill kit is for your small first aid kit, generally a bag. Recommend replacing contents on an annual basis.

■ FIRST AID KIT – REFILL (REG 7)



A Regulation 7 refill kit is for your big first aid kit, generally a metal box. Recommend replacing contents on an annual basis.

■ FIRST AID KIT – REFILL (BLOOD SPILL)



A blood spill refill kit is for all vehicle and Reg 7 first aid kits. Recommend replacing contents on an annual basis.



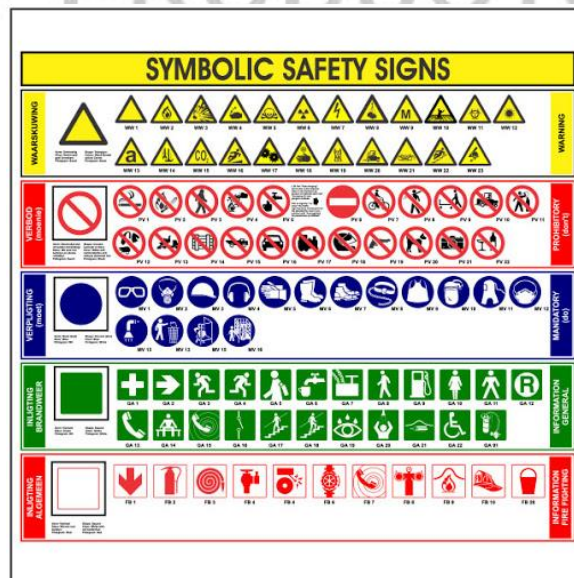
